Every visa applicant no matter their age must bring certain documents to the interview, including photographs, the original version of all civil documents submitted to NVC, copies of those documents, and financial documents from the petitioner and any other financial sponsors. Consular Officers often use the information in the DS-160 application to process the visa application and, combined with a personal interview, determine an applicant's eligibility for a nonimmigrant visa.

Differently from the European visa policy where you pay the fee at on the appointment day, for a US visa you need to pay the fee in order to be able to schedule an interview. The fee that applicants should pay depends on the type of visa one applies for.
